R. Eiden presented the Gambling Manager's Report. Gross Profit (Net Receipts) - \$58,491.00; Total Tax – \$21,738.00; Total Allowable Expenses - \$23,576.00; Net Profit (Loss) for the Month – \$8,680.00 Reconciled Gambling Fund Balance - \$190,086.80. Total of all Gambling Fund (on the last day of the month) - \$392,643.90. Reconciled Gambling Fund (on the last day of the month) - \$388,453.64. Reconciled Checkbook Balance - \$185,896.54. Motion to approve the gambling report was made by D. Belland, seconded by R.Rogosheske.. Approved. To be approved: Compensation/tax \$6,000; Rent \$20,000; Miscellaneous \$4,000; Tabs and Tax \$35,000. Total to be approved - \$65,000.00 Motion to approve was made by D. Foerster, seconded by D. Belland. Approved. Ron stated to-date, we have \$95,836 in profit. If we didn't spend this amount, the state will take 27%. Discussion followed.

Anybody can now look on the website and see what has been done. P. Flom discussed the new "No Wake" zone banners. R. Eiden asked for a motion to spend up to \$1,000 on the banners.
